Student Code of Conduct

Students are expected to conform to the following code of conduct:

- No possession, influence, or use of alcohol, drugs, or tobacco

Consent, Release, Student Agreement, and Indemnification

6. Releasor authorizes the agents of Church to make emergency medical decisions on behalf of Student in the event Releasor cannot be reached. Releasor acknowledges that he/she will ultimately be responsible for the cost of any medical care provided to Student.

9. This Release does not extend to claims of intentional acts, gross negligence, or willful or wanton conduct arising from Student's participation in above listed Event and Activities. Releasor agrees to attempt to settle all such claims through good faith negotiation with Church. If good faith negotiation fails, Releasor agrees to attempt to settle all such claims through mediation with a professional mediator. If mediation fails, Releasor agrees to that the laws of the Commonwealth of Virginia shall govern and the jurisdictional forum shall be the Commonwealth of Virginia.
